# **GOVERNANCE OF THE SAFER COMMUNITIES BOARD**

# Report by Colin Everett, Clerk to the Authority

#### **Purpose of Report**

1 To inform members of the governance arrangements for the Safer Communities Board (SCB).

# Background

- 2 At the 6th June 2014 meeting of the North Wales Safer Communities Board members agreed to formally constitute the Board as an advisory committee, in accordance with the Local Government Act 1972.
- 3 This development concludes a lengthy debate, and will clarify the Board's purpose and decision-making powers. It will now transition from being a voluntary partnership to a formally constituted committee.

# Information

- 4 The establishment of an advisory committee can be achieved within the legislation as it exists, and would need to incorporate the existing Overview and Scrutiny framework for county-level which CSP's are bound by.
- 5 At the last meeting members agreed that the Board should undertake the following tasks:
  - To commission services funded through specific regional grants
  - Strategic accountability of the North Wales Area Planning Board

- Establishing a common and consistent framework for strategic, tactical and operational delivery at regional, sub regional and local levels through the production of an annual strategic assessment and community safety plan (to be mirrored by a similar approach for youth justice).
- Identifying shared and/or common priorities in the fields of community safety and youth justice
- Acting as a formal representative voice to influence the Welsh Government, Home Office and local Policing Body.
- 6 The establishment of the new advisory committee has all partners as equal members with voting rights. It could carry out all of the desired tasks outlined above, with the exception of commissioning (unless explicitly a regional fund) because it could not be given formal delegated authority on behalf of any local authority members.
- 7 An action arising from the June meeting was for all SCB members to formally inform their respective organisations of the Board's new status as an advisory committee.
- 8 The following actions associated with the changes in governance were identified:
  - (i) Members to inform their respective organisations and local LSB/ CSP structures of the SCB's new status as an advisory committee.
  - (ii) Establish mechanisms to convey the priorities of the SCB for local and/or sub-regional consideration.
  - (iii) Revision of the terms of reference. A draft version of the terms of reference was considered by members at the 5th November 2014 meeting.
  - (iv) The final requirement was to review the membership of the Board. It is recommended only the Members and officers included in appendix 1 are standing members of the SCB.

- 9 Building on the strengthened status of the SCB, progress is now required to develop a single integrated needs assessment for North Wales. This proposal has already been agreed in principle by members, work will now commence to marry up the strategic assessment, substance misuse and DIP needs assessments. Such an approach will enable the Board to drive the regional Community Safety Plan through setting priorities, based on evidence and intelligence.
- 10 Allied to the development of an integrated needs assessment will be the requirement of a more robust monitoring framework. To this end the Board will need to consider the information required and what their expectations will be in the event of issues arising.
- 11 A further consideration is how the SCB and the Police and Crime Commissioner can mutually support each other, in terms of the alignment of shared priorities and commissioning decisions.

#### Recommendation

12 To note the contents of the report and the forward work plan attached at appendix 2.

#### Membership of the SCB

<u>Formal members</u>: Formal members are defined as representatives from the statutory partner agencies, as listed in the Crime and Disorder Act 1998. The Elected Members appointed will be expected to have sufficient seniority and experience; officers appointed will be at an appropriate level of seniority to similarly make decisions on behalf of their organisations. Appointees, whether elected members or senior offices, will have full voting rights. The statutory organisations identified by the Crime and Disorder Act 1998 are:

- Local Authorities
- Police
- Probation Service
- Fire Service
- Local Health Board

<u>Lead Advisors</u>: At present (as at November 2014) the lead executive advisors are Colin Everett (Chief Executive, Flintshire County Council) and Mark Polin (Chief Constable, North Wales Police)

<u>Standing Professional Advisors</u>: Advisors will be identified to join the Board to provide specialist advice to members. They will not have full voting rights.

<u>Co-opted Members</u>: Co-opted members will be appointed to the Board as required. They will have full speaking rights but not voting rights.

All constituent partner representatives should have sufficient seniority within their organisation to make necessary resource and policy commitments. This requirement is not intended to compromise the independence and decision-making processes of the partner organisations.

Representatives of statutory partners, as defined by the Crime and Disorder Act 1998, should be of sufficient seniority to ensure that their organisation fulfil their statutory responsibilities.

Each of the region's local authorities will be required to formally nominate an Elected Member to represent them on the Board. The other statutory authorities will be represented by officers with delegated powers from their respective organisations.

The Board will have the power to co-opt additional members as required, and should consider the representation of other major partnerships in the area.
